**ANNUAL CARE/POLY-SILKS PROGRAM/GRAVE DECORATION PLACEMENT PROGRAM**

**Annual Care-Maintain Level Sod Grave:** The Annual Care to be provided as described on the reverse of this page to maintain level sod grave, as applicable, shall be such care as, in the sole discretion of Waldheim Cemetery Co. ("WCC"), is necessary to give the cemetery a well-kept appearance, and includes, but is not limited to, individual trimming, mowing, weed control, and fertilizing of the grave site for the current year mowing season, which typically ends in October. WCC shall not be liable for any damage or delay caused directly or indirectly by any governmental action, Act of God (including but not limited to floods, lightning, earthquakes, or storms), animal damage, vandalism, war, civil unrest, labor strikes or stoppages, including labor shortage due to any of the aforementioned causes or pandemic, or any other cause beyond WCC's reasonable control. The maintenance of privately planted trees or shrubs, or any other special care, on this lot is not included, nor is any repair of stone markers or monuments. *If you are interested in endowed care, please call WCC office.*

**Grave Decorations:** Only graves with care are eligible for spring/summer and fall poly-silk bouquets. *For information about care, please call the WCC office.* All graves are eligible for the winter offerings. As described on the reverse side of this page, as applicable, all poly-silk and natural greenery decorations are leased and not sold, for the identified season only – while supplies last (color/style may vary). WCC makes no guarantee for decorations placed on graves. The winter greenery decorations are hand crafted by a local Illinois farm and are estimated for delivery to us in early December. We will place them as soon thereafter as possible. These decorations will be removed and recycled as spring approaches, at our discretion. Natural evergreens fade with time. The winter greenery option may be ordered on its own or in combination with the other grave decoration options. If decorations disappear from a grave for any reason, we will not replace them.

**Ordering Instructions:** To place an order, please return one copy of this entire form, along with payment, to Waldheim Cemetery Co. If grave decorations are not included on the reverse of this page and you would like to add to this order, please contact the WCC office or return the completed Grave Decoration Placement Program Order Form, with payment.

**Payment Options:** Payment constitutes acceptance. (a) If paying by check, please include your customer number (if applicable) on your check. (b) If you are paying by bank issued check to be sent separately from this form, please add a note on the reverse side of this form stating that the check will come separately directly from the bank. We cannot process your order until the check is received. (c) If authorizing payment by credit card, please sign where indicated and/or provide your phone number and someone from the WCC office will call you for your authorized credit card information at the phone number you provide. We accept Visa, Mastercard and Discover. *Please do not include any credit card information on the order form.*

**Receipt:** The Purchaser's cancelled check or credit card statement shall constitute the receipt for payment.

**Rules and Regulations:** The applicable grave spaces are subject to the Rules and Regulations of WCC currently in effect and as may be amended from time to time, which are available at [waldheimcemetery.com](http://waldheimcemetery.com).

**Entire Agreement:** This Agreement contains the entire agreement between or among the parties relating to the Annual Care of the grave(s) and/or grave decorations referenced herein for the time period identified on the reverse of this page. There are no understandings, representations, or agreements, written or oral, regarding the Annual Care of such grave(s) and/or grave decorations between or among the parties that are not contained herein, and all prior negotiations, conversations, and documents which may have been transmitted by or among the parties are merged herein. This Agreement may only be amended in a writing signed by all parties.

**Jurisdiction:** This Agreement is subject to and shall be construed, interpreted, and governed in accordance with the laws of the State of Illinois, and each party agrees that any suit, action, or other legal proceeding arising out of or relating to this Agreement shall be brought in the Circuit Court of Cook County, Illinois or in the United States District Court for the Northern District of Illinois. Each party consents to the jurisdiction of each such court, and waives any objection it may have to the venue of any suit or proceeding in any such court.

**Irrevocable:** This Agreement is irrevocable, except as may be provided in writing signed by both parties or otherwise provided by law. This Agreement is binding upon the heirs, legatees, devisees, executors, administrators, successors and assigns of the parties.
